Cultivation Module



The module for cultivation and harvesting practices is strongly linked to the GACP specifications and makes it easier for the cultivator to run an efficient and compliant operation. The movements of all plants and operations are directly and seamlessly inserted into the Cannavigia system, so that a clear production process is recorded in the form of a cultivation journal. This precise documentation of all work steps is essential for the traceability of the products created and protects not only the end consumer but also the cultivator from intentional malicious acts.

Manufacturing Module



The module for further processing is a further step towards a transparent and sustainable supply chain. Based on GMP specifications, the system allows efficient and transparent handling of all processing steps. This is necessary for legal requirements on the one hand, and for consumer protection on the other, and allows the company to gain a deeper insight into its work processes.



Distribution Module



All previously collected master data is bundled and fed into the logistics and distribution module, forming the basis for a completely transparent supply chain. Based on GDP (Good Distribution Practices), all movements are recorded and allow the company to control what happens to its products after they leave the cultivation and manufacturing facilities.
